      - 1. Page 4 (g)(2): removed "as long as such system is not visible from the street or road."

2. Page 5 (h)(3): This is standard language in solar ordinances. This means that the solar generated is limited to your personal use and not intended for net metering.

 Page 5 (h)(6): removed this section as it is not needed due to the small lot sizes in The Village and the limitations mentioned in (h)(5).

- a. Updates from Jon Moxey
  - i. Legacies Village
    - 1. \$50K bond for lack of completion were required and we are holding final occupancy permit until completed.

    - 4. Dead trees need to be replaced if they do not show that they are still viable.
    - 5. The standing water issues have been resolved.
