- 4. Public comment on agenda items. Jeff Kusmierz Citizen report on infrastructure and perspectives regarding Village street repairs, Village curb & gutter degradation & preventative maintenance, Village considerations of selecting a Village resident for Village manager.

- 8. Reports from Village Council Committees Enhancement Committee Taste of Caledonia on Main Street in conjunction with Family Tavern car show on Wednesday, August 7th, 5-9PM

 - a. Fleis & VandenBrink 5 Year Parks & Recreation Plan continued progress, MDOT Category B project construction due to start August September 2024.
 - b. Township Hired on call Firefighters.
 - c. DPW Foreman's Report Street maintenance, cutting grasses back, sidewalk reviews. Coordinating stump grinding, planting letters sent for tree selections. 2 tons cold patching was done on Friday. Cold patch is a temporary fix, (a couple months) it doesn't seal tight enough for moisture prevention. Hot patch not used because we do not have a hot box. (One rented previously.) Hot patch is the only long-term fix because it seals. Hot box rental 1250.00 for 7 consecutive days, not including the hot patch material. Estimated staff could lay 2 ton per day. Erskine moves to rent the hot box now and patch it all. Supported by Niles. All ayes. Cleaned out storm drain on Church St full of debris placed there by several pre-teen boys.
 - d. Managers' Report Ordinance Code, updated version received, 230 & 250 S Maple parking lots completed. Caledonia Village Centre potholes & irregular mowing concerns / noxious weeds have been conveyed to property owners. 250 Maple foyer LED lighting project has been completed. 250 Maple transition from a Type III to Type II well permit requiring several repairs, inspections & increased testing is in progress. Village office pylon sign project is on the "go slow to achieve the desired results" path. Dero Bike repair station has arrived. Elections this November. President & 3 Trustee positions on the ballot. July 23rd is deadline for submitting applications. "Cell phone lot" idea for dance parents will be floated during the summer to relieve parking pressure on Main Street. Encourage employees of downtown merchants and apartments to park in the back lots, leaving the street parking for customers.
